PROCLAMATION

OBSERVING PRIDE MONTH--JUNE 2023

WHEREAS, lesbian, gay, bisexual, transgender, and queer (LGBTQ+) communities across the country celebrate pride in their cultures and communities annually in the month of June; and

WHEREAS, the nationwide tradition of celebrating Pride in June commemorates the Stonewall Uprising that started on June 28, 1969, which marks the beginning of the modern LGBTQ+ rights movement; and

WHEREAS, the first annual celebration of Pride marked the one year anniversary of the Stonewall Uprising as a way for LGBTQ+ people and communities to gather together to remember the events of the previous year, to demonstrate against discrimination, and to express their gender identity and sexual orientation collectively; and

WHEREAS, Linn County acknowledges the continued discrimination and ongoing struggle that many LGBTQ+ people face in pursuing and living out their authentic identities in their personal lives, in the workplace, and in public arena; and

WHEREAS, Linn County recognizes the countless and invaluable contributions of LGBTQ+ people and communities that help make Linn County a more compassionate, inclusive, empathetic, and accepting place; and

WHEREAS, Linn County welcomes and accepts people of diverse sexual orientations, gender identities, and gender expressions, and is proud to celebrate the contributions and culture of LGBTQ+ residents, their friends, family members, and allies; and

WHEREAS, each year, Pride celebrations around Linn County bring together thousands of LGBTQ+ people from across Iowa and beyond to celebrate their shared identities and experiences; and

WHEREAS, Linn County wishes to join with LGBTQ+ people and communities in their annual celebration of Pride.

NOW, THEREFORE, we, the Linn County Board of Supervisors, Iowa, do hereby recognize and proclaim the month of June 2023 as

LGBTQ+ Pride Month

in Linn County and encourage residents to reflect on the ongoing struggle for equality by members of the LGBTQ+ community and to celebrate the many contributions of the LGBTQ+ community that strengthen and enhance our collective community.
