The Board met in session at the Linn County Jean Oxley Public Service Center.
Present: Chairperson Walker (watching on Facebook live), Vice Chairperson Rogers and Supervisor Zumbach. Board members voting "AYE" unless otherwise noted.

Vice Chairperson Rogers called the meeting to order.
