The Board met in session at the Linn County Jean Oxley Public Service Center.

Chairperson Walker called the meeting to order.

Joe Lock, Pres. & CEO of the Eastern Iowa Health Center (EIHC), gave a presentation  
regarding the EIHC (a non-profit that provides health care to all regardless of  
ability to pay).
