

Video Discovery Ordering Process

Ordering of video evidence is done online via our website. There are forms online that need to be filled out completely and submitted. When you click the submit button an email with the information will be sent to the respected agencies and/or departments. They will gather the requested information send it to the County Attorney's Office. Once we receive ALL the requested information, it will be packaged, uploaded to Evidence.com and you will receive an email with a link to download the videos (see Evidence.com Download Email for an example).


